

The Open Invitation – Terms & Conditions

1. Promotional Period

The promotion runs from **15 April 2026 to 14 December 2026** (“Promotional Period”). All qualifying winners must be entered by **14 December 2026**, with the Grand Draw winner notified by **18 December 2026**.

2. Eligibility & Entry

2.1 Entry is open to New Zealand residents aged 18 years or older who participate in a golf day sponsored by Gallagher during the Promotional Period.

2.2 To enter, participants must win the **Closest to the Pin** competition at a golf day where Gallagher is an official hole sponsor.

2.3 Each Closest to the Pin winner automatically qualifies for **The Open Invitation Grand Draw** (“Grand Draw”).

2.4 One entry per qualifying event winner. Entries cannot be transferred, assigned, or exchanged.

2.5 Employees of Gallagher are not eligible to participate in the Competition.

3. The Prize

3.1 The Grand Draw winner will receive a **2027 New Zealand Open experience for two people**, valued at approximately \$3,500.

3.2 The prize includes:

- Return **Air New Zealand** flights for two from the winner’s nearest airport to Queenstown.
- Both attendees must travel on the **same flights**.
- Departure on **Friday 26 February 2027**.
- Return on **Sunday 28 February** or **Monday 1 March 2027**.
- **Three nights’ premium accommodation** (Friday 26 February – Monday 1 March 2027) at Sudima Queenstown, or similar accommodation selected by Gallagher, in a double or twin-share room.

- Hosted hospitality for two in Gallagher’s premium offering at the **2027 New Zealand Open**, on **Saturday 27 February and Sunday 28 February 2027**.
- All food and beverages are provided within Gallagher’s hospitality offering.

3.3 Any expenses not expressly included in the prize (including transport to/from airports, insurance, incidentals, meals outside the hospitality offering, and personal spending) are the responsibility of the winner and guest.

3.4 The prize is not transferable, exchangeable for cash, or refundable.

4. Winner Notification & Acceptance

4.1 The Grand Draw will be conducted by Gallagher or its appointed representative after the Promotional Period ends.

4.2 The winner will be contacted using the details provided via their qualifying event entry.

4.3 If the winner cannot be contacted within **five (5) business days**, Gallagher may, at its discretion, redraw the prize.

4.4 Gallagher may require proof of identity, age, and eligibility before confirming the prize.

5. Travel Requirements

5.1 The winner and their guest must be available to travel on the specified dates.

5.2 Changes to flights, accommodation, or travel arrangements outside the stated prize inclusions are the responsibility of the winner and may incur additional costs.

5.3 The winner and guest must comply with all airline, accommodation, and event policies and requirements.

6. Marketing & Publicity

6.1 By accepting the prize, the winner and guest consent to Gallagher using their **name, image, likeness, video, and/or photographs** for promotional and marketing purposes related to The Open Invitation or future Gallagher promotions.

6.2 This usage may include (but is not limited to) social media, website content, EDMs, event collateral, and media relations, without further compensation.
